APPLICANTS MUST BE 18 YEARS OLD, COMPLETE A MATH ASSESSMENT EXAM, ATTEND A SCHEDULED ORAL INTERVIEW AND SUBMIT THE FOLLOWING DOCUMENTS IN PERSON:

- Copy of Birth Certificate *and*
- Copy of a High School Diploma with Transcripts *or* copy of a G.E.D.
**or* complete the requirements to receive either a High School Diploma or a G.E.D. prior to the end of the apprentice's probationary period *and*
- Copy of DD214 or Discharge Papers, if applicable *and*
- Documentation that establishes both Identity & Employment Eligibility (USA Passport/Certificate of USA Citizenship/Government issued ID with photograph, name, DOB, sex, height, eye color, address)

Selection of top applicants made by the Committee based on numerical score. Qualified applicant not selected shall be placed on a waiting list for a maximum of two years and are eligible to reapply.

Applicants must be able to perform the essential function of the trade with reasonable accommodation. Applicants must be legally residing and legally eligible for employment in the United States, genuinely interested in learning the trade, and willing to comply with all terms and conditions set forth by ABC, The State Apprenticeship Council and The Bureau of Apprenticeship and Training.
